Please register your group using the [online group booking form](#).

- On the online registration form, you can register your group manager and select the number of registrations required for each category. Please note that all bookings made are subject to the [General Terms & Conditions](#), including the cancellation clause. Kindly be aware that unused registrations will not be refunded.
- After completing your group registration via the link above, you will receive an email containing the payment order/pro forma invoice and the official name list template to provide the details of your group members.
- **Payments** can be done by bank transfer and they are only accepted in Euros. All bank transfer fees (including any charges incurred by the receiving bank) must be covered by the sender. Payments must be received by the upcoming deadline to avoid registrations being automatically adjusted to the next higher fee.
- The deadline to submit the completed **name list** is 17 September 2025 (23:59 CEST). Until this date, name changes are free of charge. After this date, a name change fee of EUR 50 (excluding any applicable VAT) will apply for each name change. The EACS Conference Secretariat will not accept name lists that do not adhere to the official template or that are missing mandatory information.
- All participants registered in the Allied Health Professional category must provide official **proof of eligibility**. This registration fee is specifically for nurses, social workers, students, research fellows, and community members. To confirm registrations in this category, please submit current proof of eligibility in English (such as a student ID or proof of association membership) via email. The deadline to submit proofs is 17 September 2025 (23:59 CEST)
- **Tax invoices** will be issued only after the conference.
- It is the group leader's responsibility to ensure that each delegate is registered only once. No refunds will be issued for duplicate registrations.
- Should the pre-paid amount not be used in full during the pre-registration process, the remaining amount can be used for additional registrations. There will be no refund for paid and unused badges.
- The [terms & conditions](#) are fully applicable to all participants registered under a group registration.
