GENERAL TERMS AND CONDITIONS

Definitions

K.I.T. Group GmbH Association & Conference Management is the Professional Congress Organiser (PCO) of the 2018 Joint International Congress of ILTS, ELITA & LICAGE, May 23-26, 2018 in Lisbon, Portugal. The is responsible for registration services, abstract management, sponsorship opportunities, exhibition management and social events and is hereafter referred to as K.I.T. Group.

These General Terms and Conditions are valid for each attendee registered for the 2018 Joint International Congress of ILTS, ELITA & LICAGE, May 23-26, 2018 in Lisbon, Portugal (hereafter referred to as the "Congress"). Any registered person is considered an attendee.

Congress Registration / Payment

The registration deadlines are as follows:

Early Bird Registration	until January 11, 2018, 24:00 CET
Standard Registration	until April 26, 2018, 24:00 CET
Late Registration	until May 22, 2018, 18:00 CET
Onsite Registration	from May 23, 2018

Only fully completed and signed registration forms will be accepted. The registration will only be confirmed upon receipt of payment in full as well as a proof of status if required (please refer to paragraph "Proof of Status"). If the registration form and/or the full payment and/or the proof have not been received before the deadline indicated, the registration will be cancelled OR the next registration fee will automatically be charged.

To be registered under the ILTS Member fees, the full membership number must be provided by the published deadline. Furthermore, the delegate must have an active membership at the time of registration. No refunds will be made for delegates who acquire or renew their membership after the registration has been confirmed. Please verify that your membership is active and includes the eligibility to the preferential Congress fees prior to registering for the Congress. All registration and course fees include 23% Portuguese VAT. Payment by bank transfer is only possible until May 20 2018 24:00 CET. The registration fee includes admission to the Scientific Sessions and the Exhibition. The Closing Reception Event is not included in the registration fee.

The official Congress language is English and no translation will be offered.

If the maximum attendee capacity is reached, the organisers reserve the right to refuse any registration.

Registrations for more than ten persons will be handled separately as a group booking. Please contact the ILTS Congress 2018 Registration Department.

Proof of Status

To register as a Non-Member Associate, or as a Trainee the required proof must be forwarded by the published deadline (together with the registration fee).

A Proof of Status is an official letter written by the head of department – hospital, company or academic institution, which confirms the status of the applicant. The document must be issued in English on the organisation's official letterhead.

When letters, certifying status, are sent after the Early Bird / Standard / Late registration deadline, the next registration fee will be applied even if the online registration was completed within the deadline.

Letter of Confirmation/Payment Receipt/Invoice

A letter of confirmation/payment receipt/invoice will be sent by email after the ILTS Congress 2018 Registration Department has received a fully completed and signed registration form, the related full payment and if applicable the required proof of status.

Congress Materials

If the registration form and full payment are received no later than the early registration deadline, a congress bag is included in the registration fee for delegates, students, speaker and media representatives. If the registration form and/or full payment are received after the early registration deadline, K.I.T. Group cannot guarantee that a congress bag will be available. All congress materials will be handed out on-site at the registration counter.

Registration Name Change / Lost Name Badge

A handling fee of 50 USD will be charged for every name change to an existing Congress registration. Name changes will only be accepted by email or fax indicating the new and old name and only until May 22, 2018. After this date, all name changes must be carried out onsite and a written notification of the person being replaced must be presented. For a lost name badge a fee of 50 USD will be charged.

Cancellation Policy / Refund Policy

Notification of cancellation must be made in writing and sent to the ILTS Congress 2018 Registration Department by email or fax by April 26, 2018 24:00 CET. The refund of the registration fee, less a 75 USD administration charge, will be made after the Congress. No refunds will be made for cancellations after this date. Any refund claims must be sent by April 26, 2018. The cancellation policy also applies to the Closing Reception Event. No refunds will be granted for unattended sessions or early termination of attendance. As mentioned below (please read "Visa Requirements" below), it is the sole responsibility of the participant to take care of his/her visa requirements. Exceptionally, in case of a visa application rejection, refunds will be made provided that the visa application was filed in due time (before March 23, 2018) and provided that a document from the Embassy is sent immediately after the rejection to the ILTS Congress 2018 Registration Department. These two conditions are cumulative. Please note that a notification sent to the ILTS Congress 2018 Registration Department after the Congress will not be accepted.

Media

To register as a media representative, please contact the ILTS Congress 2018 Registration Department in order to receive a media registration form. There is no registration fee for accredited media representatives. However, to register as a media representative, you must submit a copy of your official press card.

Certificate of Attendance

A Certificate of Attendance will be available electronically after the Congress. Delegates will be required to complete a survey prior to receiving the Certificate of Attendance.

Modification of the Programme

The ILTS reserves the right to modify the programme, which is published as an indication only.

Cancellation of the Congress

In the eventuality that the ILTS Congress cannot be held or must be moved or changed due to

- Any reason(s) beyond its control that prevent or substantially hinder the plane of holding the Congress
- Unforeseen political and economic events, acts of God, national emergency, national mourning, strike/demonstration, closure of airports or any other event of "Force Majeure"
- Its status as medical association compelling ILTS to consider particularly the potential health risks (e.g. pandemic flu) of the Congress to participating doctors and their patients

The ILTS cannot be held liable by participants for any damages, costs, or losses incurred, such as transportation costs, accommodation costs, financial losses, etc. Under these circumstances, the ILTS reserves the right to either retain the entire registration fee and to use it for a future ILTS Congress, or to reimburse the registration fee after the deduction of costs already incurred for the organisation of the ILTS Congress and which could not be recovered from third parties.

Letter of Invitation

Participants requiring an official Letter of Invitation should contact the ILTS Congress 2018 Registration Department. To receive a Letter of Invitation, participants must be fully registered to the Congress and payment in full must be submitted. The attention of the participants is drawn to the fact that the Letter of Invitation must be requested sufficiently in advance and that the Letters of Invitation will not be sent after May 22, 2018. The Letter of Invitation does not financially obligate the ILTS in any way. All expenses incurred in relation to the ILTS Congress are the sole responsibility of the participant. Any costs for express mailing of documents must be covered by the participant.

Visa Requirements

It is the sole responsibility of the participant to take care of his/her visa requirements. Exceptionally, in case of a visa application rejection, a refund minus a 75 USD handling fee will be made provided that the visa application was filed in due time (before March 23, 2018) and provided that a document from the Embassy is sent immediately after the rejection to the ILTS Congress 2018 Registration Department. These two conditions are cumulative. Please note that a notification sent to the ILTS Congress 2018 Registration Department after the Congress will not be accepted.

Children

The minimum age for a participant is 18 years old. Children under the age of 18 will not be allowed access to any part of the Congress.

Accompanying Persons

Due to changes in the pharmaceutical industry code of conduct, the ILTS is no longer able to grant access to the Congress for accompanying persons. The Congress is only accessible to certified healthcare professionals, associated press, industry representatives and other stakeholders in the science and management of liver transplantation.

Data Protection and Sharing of Contact Details

In order to protect and safeguard the personal data provided to us, we have implemented and use appropriate business systems and procedures. For example, your credit card information is transmitted to us through a secure server protocol, which encrypts all your personal and credit card details. The encryption method used is the industry standard "Transport Layer Security (TLS)" technology. Our TLS certificate has been issued by utn.usertrust.com.

Furthermore, we have implemented and use security procedures and technical and physical restrictions for accessing and using personal information. Only authorized employees are permitted to access personal information for performing their duties in respect of our services.

Our server and network are protected by firewalls against unauthorized access and we have intrusion detection systems that monitor and detect unauthorized (attempts to) access to or misuse of our servers.

Your credit card details will be kept by K.I.T. Group until three months after the end of the congress and thereafter safely deleted.

In addition, the congress organisers periodically share contact details of attendees with third parties that may use these details to contact attendees regarding activities at the congress or other communications which may be of interest. Therefore, data might be passed on to third parties unless otherwise explicitly indicated by the attendee. Your complete contact details will only be forwarded if:

- your explicit consent is given,
- a third party has proven to the congress organisers that you have violated the rights of this third party and has thus demanded the disclosure of your data, or
- the congress organisers are obliged to give out your data due to for example a court order or an official order.

Attendees can use the name badge with the Barcode / QR Code like a business card with any congress exhibitor and/or satellite holder to give them the complete contact details. In this case you decide to whom you provide your data. Please note that offering your badge to be scanned at an exhibition stand and/or at the entrance to a satellite symposium implies your acceptance that the respective company receives your complete contact details from the organisers and may contact you, using this data.

This agreement shall be subject to German law. The event itself shall take place in Lisbon, Portugal, and to the extent permitted by mandatory local law, in the event of any legal claims arising from either party Berlin, Germany shall be the sole court of jurisdiction.
